This is to advise you that on May 9, 2023, at a regularly scheduled meeting of the Henry County Board of Ethics, the Board voted by majority action that:

there **is** probable cause warranting a formal hearing on a violation of the following: Misuse of Position (section 22(c)(4)), Conflict with Official Duties (section 22(c)(5)), Engaging in Activities Prohibited by Law (section 22(c)(7)), and Inappropriate Conduct by a Member of the Board of Commissioners (section 22(c.1)) of the Henry County Ethics Code.
